

## **Man Yue Technology Receives Productivity and Quality Grand Award in the Hong Kong Awards for Industries**

(27 October 2013 – Hong Kong) – **Man Yue Technology Holdings Limited** (“Man Yue Technology” or the “Group”) (stock code: 00894), one of the largest Aluminum Electrolytic Capacitor (“E-Caps”) and Conductive Polymer Aluminum Solid Capacitor (“Polymer Caps”) manufacturers in the world, has been awarded the Productivity and Quality Grand Award in the Hong Kong Awards for Industries.

The Hong Kong Awards for Industries is organised by the Hong Kong Productivity Council. Man Yue’s award entries thus honoured were its “Screw Rotary Riveting Laser Welding Technology” and “Integration of Snap-in Sorting and Packing Workflow”.

The “Screw Rotary Riveting Laser Welding Technology” made the Group the first screw terminal type manufacturer in the world to combine laser welding technology with mechanical rotating riveting technology, which lowers welding resistance after riveting, and boosts ripple current endurance. This technology thus enhances quality, reliability and consistency of the products as well as shortens the production cycle. The “Integration of Snap-in Sorting and Packing Workflow” technology uses automation to reduce manual operation, together with the application of instant computer storage technology, defective products and unstable performance can be quickly and more accurately identified and removed. The two new technologies effectively bolster production efficiency and improve product quality and output. The Group’s technology has again been honoured further to being awarded the “Hong Kong Awards for Environmental Excellence ‘Class of Excellence’ Productwise Label (RH Series)” by Environmental Campaign Committee in 2011.

The key focus on R&D in innovative technologies and enhancing production capacity has enabled the Group to maintain its leading position as a major global manufacturer in the international capacitor industry.
