**VOTING RESULTS OF ANNUAL GENERAL MEETING
HELD ON 10 MAY 2018**

At the annual general meeting of the Company held on 10 May 2018, all proposed resolutions as set out in the notice of AGM dated 30 March 2018 have been duly passed by the shareholders of the Company.

At the annual general meeting of Man Yue Technology Holdings Limited (the “Company”) held on 10 May 2018 (the “AGM”), all votes on all the proposed resolutions as set out in the notice of AGM dated 30 March 2018 were taken by poll. As at 10 May 2018, the total number of issued shares of the Company entitling the holders to attend and vote for or against the resolutions at the AGM was 475,547,534 and there were no shares of the Company entitling the holder to attend and vote only against the resolutions or abstain from voting at the AGM.
