Man Yue Receives 2008 Hong Kong Awards for Industries: Environmental Performance Certificate of Merit

(22 January 2009 – Hong Kong) — **Man Yue International Holdings Limited** (“Man Yue” or the “Group”) (stock code: 894), the fifth largest aluminum electrolytic capacitors (“E-Caps”) manufacturer in the world, was awarded “2008 Hong Kong Awards for Industries: Environmental Performance Certificate of Merit”, for its efforts in environmental protection.

The annual “Hong Kong Awards for Industries” is co-organised by seven trade and industrial organisations to honour outstanding achievements of Hong Kong enterprises in seven aspects. The “Environmental Performance” category is organised by the Business Environment Council comprising a representative cross-section of Hong Kong businesses and dedicated to promoting sustainable development in the city. Companies competing under the category are evaluated by independent industry representatives and environmental experts on their commitment to environmental protection, such as in adopting new technologies to minimise adverse impacts of their operations on the environment and compliance with applicable environmental legislations.

As a committed supporter of sustainable development and environmental protection, Man Yue is the first E-Caps manufacturer in China to own sophisticated RoHS compliant equipment comparable to those used by certification institutes and other organisations keen in observing related procedures. Apart from ensuring its manufacturing plants comply fully with relevant environmental protection regulations and other stringent standards in different markets, it also educates vendors and encourages them to observe relevant environmental standards. Implementing environmental protection management systematically and diligently over the years, Man Yue was ISO14001 accredited in 2004.

Over the years, the Group has executed several energy saving and emission reduction plans without sacrificing productivity. It was able to reduce electricity consumption and electrolyte emissions significantly since 2004, which has resulted in approximately HK\$13 million worth of cost savings per annum.

The Group has been relentlessly in pursuing the research and development of energy efficient and eco-friendly products in response to the increasing global concern on environmental protection. In 2004, the Group partnered with the Research Institute of Tsinghua University in Shenzhen to co-establish and run a scientific research centre in Shenzhen. Focusing on technology researches and improvement of quality and productivity, the research centre has enabled the Group to pursue product innovation, explore new applications of materials, gather production and engineering information and develop relevant technologies. In 2007, the research centre started to develop the Electric Double-layered Capacitor (“EDLC”), which is an innovative device with strong energy saving and storage capabilities. The Group also employs over 100 qualified professionals in its various R&D teams across the Group.

Mr. Eugene Chan, Managing Director of Man Yue, said, “We are pleased to receive the honour testifying our efforts and achievement in environmental protection. It will remind us to continue to step up related efforts and explore new green manufacturing practice and methods.”
